Limited Review Report for the Quarter ended 30th June, 2018

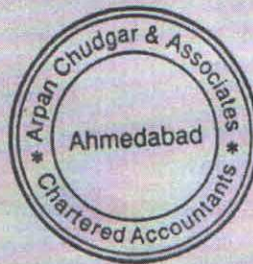
